## Saint Andrew School-MEGA Raffle 2024 Official Rules Sheet

- 1. Must be 21 years of age to purchase and/or sell tickets. Only one (1) individual may be identified as the purchaser (or buyer) of the raffle ticket. Please note groups must designate a primary name, address, and phone number on a ticket to be responsible for tax liability. You may add up to nine additional names per ticket (for a total of 10) at the time of purchase. No additional names may be added after initial ticket purchase. Tickets may be purchased by calling 866-862-7282, by mail, at Saint Andrew School, from a raffle salesperson or online. The primary buyer of the ticket will receive verification of purchase through their cancelled check, credit or debit card statement, or receipt of the ticket stub(s) from cash payments only. Saint Andrew School and its volunteers assume no liability for lost, late, misdirected, illegible or undelivered entries.
- 2. Saint Andrew School families are required to sell ten raffle tickets (not including incentive tickets).
- All ticket sellers will be solely responsible for monies received through ticket sales until tickets and monies are
  delivered to the Saint Andrew School office, Saint Francis Xavier business office, Newman Center business
  office, or a designated collector. It will be the seller's responsibility to receive a receipt from any collector for all
  cash sales.
- 4. Only the first 5,000 sold tickets, and their corresponding incentive tickets, received by Saint Andrew School will be entered in the raffle. Other monies will be returned to the sender.
- 5. In the event that a minimum of \$250,000 in tickets are not sold by April 15, 2024, the committee reserves the right to withdraw the prizes not awarded and pay 50% of the net proceeds up to \$100,000 to one winner.
- 6. Checks and or credit cards that are denied or returned for insufficient funds or other reasons will be subject to a penalty, and the ticket will be void until cash, or a money order is received to cover said ticket.
- 7. The primary person named on the ticket will be awarded the prize and be responsible for all taxes (Federal and State) incurred. No portion of the cost of the ticket is tax deductible. Saint Andrew School is required by law to report winnings of \$600 and over (on all drawing winnings including the 50/50) to the Internal Revenue Service and to withhold appropriate taxes on winnings of \$1,000 and over. Winners must claim possession of the prize by June 6, 2024, or forfeit the prize.
- 8. The early bird drawings will be held between 6:00 P.M. and 7:00 P.M. on the following dates: Friday, February 9, 2024, Friday, March 8, 2024, and Friday, April 12, 2024. Winners will be notified, and prizes mailed to the primary name and address on the ticket. Main drawing will be held after the conclusion of the Kentucky Derby CST, on Saturday, May 4, 2024, at Big Muddy Brewing in Murphysboro, Illinois.
- 9. All employees and volunteers of Saint Andrew School, Saint Andrew Church, Saint Francis Xavier, and the Newman Center are eligible to win drawings. However, Saint Andrew School and organizations affiliated with the faith centers are not eligible (examples: Home & School Association, Booster organizations, special fund drives, etc.).
- 10. Early bird drawing winners are eligible for all subsequent drawings. For the main drawing, winners will be drawn from the grand prize through the 10<sup>th</sup> prize. Prizes for the main drawing will be announced in reverse order. A complete winner list will be posted on Saint Andrew School Facebook page and is available by mail per request. All winners, by entering, authorize Saint Andrew School to publish their name and likeness on the website, Facebook and for it to be used in other promotional materials by Saint Andrew School.
- 11. If no parish is designated for 10% of the net proceeds' donation, proceeds will benefit Saint Andrew School. The parish business offices may designate its parish on any ticket purchased or delivered to it.
- 12. Incentive Tickets For every two tickets purchased at <u>one time</u> by an individual or group of 10 or fewer individuals, a free ticket will be included in all upcoming drawings while ticket supply lasts. For every three tickets purchased at <u>one time</u> by an individual or group of 10 or fewer individuals, two free tickets will be included in all upcoming drawings while ticket supply lasts. For every five tickets purchased by an individual or group of 10 or fewer individuals, an additional five free tickets will be included in all upcoming drawings while ticket supply lasts. The first 5000 sold tickets, and their corresponding incentive tickets, will be included in the drawing. <u>Tickets must be purchased in a single transaction by the same primary ticket holder to qualify for incentive tickets.</u>
  Single ticket purchases over time will not be accumulated to qualify for incentive ticket(s).

13. If the amount paid is insufficient to cover the number of tickets submitted, only the number of tickets covered by the payment will be included in the drawing. (i.e., if five completed tickets are submitted with a \$200.00 payment this will result in only two paid tickets and one free ticket being included in the drawing.)
